Subject: Regulation (EC) 1907/2006 (REACH)

Dear Customer,

We would like to inform you that in accordance with art. 3 (33) REACH, TGD–Thermo Glass Doors SpA is identified as producer and supplier of articles.

To comply with REACH obligations, TGD–Thermo Glass Doors SpA has established an internal process based on information transmitted by our value chain, strengthened by a continuous assessment of the trustworthiness of the supplier and of the probability of SVHC-CL (Substances of Very High Concern - Candidate List) being present in materials, parts or sub-assemblies purchased.

In accordance with art. 33 of REACH Regulation, in the Annex I we transmit the currently available information about the SVHC-CL contained in the supplied products in concentration above the 0,1% w/w, calculated as described in the judgement of the European Court of Justice of 10 September 2015 - C106/14. Information referred to the Candidate List of substances of very high concern for Authorization as last updated (<https://echa.europa.eu/it/candidate-list-table>).

Articles that contain SVHC above 0,1% w/w must be notified by the supplier to the new SCIP database, in accordance with directive (EU) 2018/851 of 30 May 2018 amending directive 2008/98/EC on waste (WFD). We inform you that TGD–Thermo Glass Doors SpA has submitted the notification by use of the grouping approach and SCIP numbers are available in Annex I. Also, we confirm that all the articles we supply are compliant to Title VIII and Annex XVII REACH requirements "Restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures and articles".
